## Aurora Labs Enhances Large Format Technology

## Prototype

Aurora Labs Limited ("Aurora" or "the Company") (ASX:A3D), is pleased to announce that it has conducted further parameter testing on the Large Format Technology prototype.

Aurora recently tested a very high-end control system for its Large Format Technology Prototype, which has resulted in an immediate increase in speed, accuracy and size of the 3D printer bed. The Company has now released a video which showcases this advancement. The video displays the system melting a 100mm square and successively smaller squares, which is one of the standard tests Aurora conducts to check the accuracy of control systems.

The print was filmed in real time, and while it is at a fraction of the ultimate speed targeted for the Large Format Technology, it is indicative of the technology's potential.

This will allow us to achieve a larger bed size with the Medium Format Printer than previously predicted and gives us much finer control and resolution while simultaneously increasing its speed. This provides further confidence towards reaching our next milestones of printing complex parts, and the development and commercialisation of our Large Format Technology."
