RESULTS OF AGM AND SPECIAL MEETING OF CLASS C PERFORMANCE SHAREHOLDERS

Aurora Labs Limited ("Aurora" or "the Company") (ASX: A3D) is pleased to provide the results of the Annual General Meeting (**AGM**) and the Special Meeting of Class C Performance Shareholders both held this morning.

All Resolutions put to shareholders at the AGM were passed by way of a poll except Resolutions 3 and 9 which were not carried.

The Company advises that Resolution 1 to consider the Remuneration Report had more than 25% of votes cast against it. As a result, this constitutes a "first strike" for the purposes of section 250U of the Corporations Act 2001 (Cth) (Corporations Act).

The Company also advised that the single resolution put to shareholders at the Special Meeting of Class C Performance Shareholders was carried by way of a poll.

Details of each resolution put to the respective meetings, proxy votes and votes cast on the poll are attached in accordance with the requirements of the ASX listing rule 3.13.2 and Section 251 AA of the Corporations Act.
